- c. **Submission of Information Letter (1st allottee) and Transfer Allocation Letter (subsequent allottee) to Transfer Branch is also mandatory, however may be done even after ballot.**
- d. Adjustment Application through email / courier not received by 19 February 2021, will not be entertained.
- e. Plot holders not willing to opt this scheme, may continue to retain his old plot / Sector.
- f. Depending upon availability, plot will be allotted similar (feature / non-feature) to previous allotment, however it is not obligatory hence no claim in the regard will be entertained.
